#### AGM Topic: Proposal to establish Wharf Capital Fund

to be funded by:

Funds remaining from 2019 rebuild project \$ 6,000.00

Additional Funds from current Bank account \$ 6,000.00

\$ 12,000.00

Proposed that in 2019, Granthams Wharf Association set aside \$12,000

Motion: in a special Capital Replacement Cost Fund, Identified as separate from general operating funds. The intention will be to add to this fund, as revenues are available, as determined annually by the membership at the AGM.

Funds will be used to cover major expense for wharf repairs and improvements,

as required, at the discretion of the Board of Directors.

#### GWA Tenure renewal completed:

The GWA historically holds the License of Occupation from the Province of BC, Ministry of Lands, Forest and Natural Resources, for the foreshore and water area upon which the wharf resides. The current agreement is for a period ending June, 2027 and is renewable at the end of each 10 year period. The cost is a nominal \$1, with a \$1000 security deposit paid to the Province.

## Plans for Granthams Post Office



  - Provide 5 suites in house and cabin for tourist accommodation


#### What we can offer:




#### From the GWA Board:
